The first day of Iowa Legislative Session will be January 10, 2022. The Committee reviewed the Association of ECI Area Boards and Advocates Legislative Agenda. Erika Fuentes serves on the Iowa Governor's Child Care Task Force and was able to provide an update about what recommendations we can expect to come out of the Task Force. Governor Reynolds is anticipated to prioritize these recommendations.

National Family Support Certification Exam

Deadline is December 31, 2021

Exam Waiver:

Any home visitor that is seeking a waiver to extend the time they have to prepare for the exam, must have their waiver submitted by December 15, 2021 close of business.

WHO:

<u>First Group:</u> Family Support Direct Service Professionals that were hired on or before January 1, 2021 that have NOT earned the National Family Support Certification by December 31, 2021.

<u>Second Group</u>: Anyone that was hired between January 1, 2021 to March 31, 2021 that has NOT earned the National Family Support Certification and is concerned that they will not earn it by March 30, 2022.

The waiver is specifically for persons that may have difficulty with achieving a passing score and could benefit from more preparation time. To be successful in being granted a waiver, persons seeking the waiver must take advantage of the numerous supports available to them prior to submitting the waiver request.

Shelly Conover – Northwest Area Education Agency: Upcoming Human Trafficking Training Certification – stand by for the date. Centering on Centers (January 28th and 29th of 2022) is complicated because of Hilton Garden Inn Hotel mandate that anyone who stays or holds a conference that uses public dollars must comply.

Kinder Fest June 17th and 18th. Was suggested to have Kids Fest at that time as well.

Linsey Gilbert – Community Action Agency of Siouxland: Kidzone and Little Raptures are struggling with staff. They are contacting parents asking what days they can keep their children home to try to stay in ratio. There are DHS dollars for programs that increase slots. Right now they are pulling high school students to fill the gaps

Megan Miller – Siouxland District Health Department HOPES: Having trouble recruiting in Ida.

Lexy Klemish - Siouxland District Health Department HOPES Program: Ida recruitment issues compounded by the fact that they are not allowed to approach WIC families because of confidentiality. SDHD HOPES is looking to fill 15 more slots (Lutheran Services in Iowa received funding for 5 more slots). They are looking for Bilingual Spanish or French speaking family support worker.

Baily Hill – Child Care Resource and Referral: The governor's task force released money for 2 grants for child care providers: Stabilization Grants and the Child Care Challenge Grants. Information about these grants can be found on DHS's website. DHS has updated some of their rules and regulations including ratios for children in Child Development Homes, all the information can be found

Last Designation was SFY 2020 – we were given an extension for Covid Next Designation - Submit Materials October 31, 2024 (Mid-Cycle April – October 2022) This next RFP will be written for 3 years for FY2023 through FY2025 So that the new SHIP ECI RFP will then be written for (4 years) SFY 2026 through SFY 2030 that will then align with the next Designation
