ECI Areas annually submit (by September 15) data and other information that supports items in the lowa Code and/or guidance adopted by the ECI State Board. As a part of the process, the ECI Technical Assistance team reviews the reports submitted and provides feedback to the area board. This work began in October. If there are any discrepancies between the reports, it is addressed. ECI Stakeholders Alliance Meeting: The Alliance will meet via Zoom on September 13, 2022 from 9:00am to 11:00am. During this meeting stakeholders broke into small groups to focus on each of the five strategic plan goals. An electronic worksheet was utilized to capture feedback for strategies and action steps for each of the goals. The worksheet was the same format the ECI State Board utilized during their September 9, 2022 meeting. The purpose of the Alliance includes:

Reports provided state averages as well as individual program information for each county served. Reports were color coded to show when data was significantly lower than expected and also when performance was higher than state averages. Technical assistance and follow up has been provided to specific areas where there was questionable data. Best training ever of my entire career!" MIECHV Innovation Grant Work is underway on translating and validating the National Family Support Certification Exam in Spanish. Key words in the exam are being identified for translation into an additional five languages. The additional five languages are based on the most common languages spoken amongst enrolled families in Iowa and Virginia. Relational competencies are in the process of being identified as our academic partner completes a literature review. Module usage has been reviewed to identify usage patterns and narrow down the list of possible modules for translation and cultural interpretation to twenty. A focus group of Spanish speaking home visitors will make the final selection of nine modules. The evaluation plan is in the process of being drafted and will be submitted to HRSA for approval in mid-November. Nine2Thrive A pilot, called Nine2Thrive (N2T), has been in operation for the past two years in select prenatal clinics in Polk and Wayne County. N2T places a Resource Specialist in the prenatal care clinic setting. The Resource Specialist assists mothers with their non-medical

needs and preparations for the new baby. The purpose of N2T is to achieve a healthy birth outcome and reduce maternal stress. 84% of the pregnant women enrolled in N2T reported high maternal stress. The Resource Specialist identifies families that could benefit from on-going support and refers to available home visiting programs. All services are voluntary, however 75% of pregnant women that were referred to N2T enrolled in the program. There are variations in the service delivery model. Wayne County adopted a universal model with the medical team referring all pregnant women to N2T. The Polk County sites utilized a risk assessment and only referred high risk pregnant women. The program has benefitted from an external evaluation annually. Medical providers reported that pregnant women in N2T attended more of their prenatal appointments. Clinical administrators reported that they were able to increase their patient load because of N2T services allowing the medical team to focus on the medical needs of the pregnant woman. N2T participants had a slightly lower rate of pre-term births than the statewide average (9.7 N2T and 9.9 lowa.) lowa is actively pursuing additional funding streams to expand the program to more prenatal clinics and continue the evaluation.

Agency Updates / Other Business

Sue Moran, Director of Early Childhood Services, NWAEA - We are working collaboratively (once grants are awarded) with Title V partners to ensure that children who are not eligible for Early ACCESS will have developmental support from a Title V agency staff member.

We continue to provide support to Stella child care and a multitude of other childcare providers for collaborative services through Early ACCESS and/or child find for those aged 3-5.

Brenda Jenkins, Early Childhood Consultant, NWAEA https://www.smore.com/35trw. It contains many of our updates & training being offered.

Mallory Berkenpas, Early Childhood Service Coordinator, LSI - Mallory went through HFA Peer Reviewer Training early November and is now a Peer Reviewer. This will benefit our local program in terms of quality. Mallory is almost done with her Infant Mental Health Endorsement. The goal is for our whole team to be IMH endorsed. Alyssa Silver, a LSI home visitor and LSI-HFA family presented to John Hopkins School of Social Work in November re: "Justice Involved- Women and their Children in Evidence-Based Home Visiting Programs: Insights from Frontline Staff". The presentation included the experiences the program has faced serving justice-involved families, the unique challenges these families face navigating things like housing, employment, parenting, etc., and how we can do better/our vision of what that would look like across systems. MIECHV Reauthorization is being voted on this week, which would provide funding to home visitation programs across the United States for another 5 years. The issue is the redistribution of funds to larger states which will impact funding to lowa. We are unsure how this will look, yet.

Amber Kollbaum, Child Care Consultant, CCR&R - Amber Kollbaum (me) covering all of Woodbury county now

\$500 incentive for all CDH who complete ChildNet Certification this year

Mid-Sioux was contracted to hire 2 Social Emotional Behavior Mental Health Specialists – Their priority is to help build the CCR&R coaching system statewide. This includes offering practice based coaching for child care consultants; supporting CCR&R as external coaches for centers participating in PBIS-Program Wide; and supporting child care programs by working with Child Care Consultants on behavior and mental health issues.

Mid-Sioux received the contract for Child Care Collaborative of Iowa – Financial Management Consulting for the whole state. Currently 6 staff have started as Financial Management Consultants with a goal to hire a total of 13 staff members. This program is intended to help providers fully utilize a Child Care Management System approved by the state (brightwheel or Playground); receive intensive coaching regarding financial and employee issues; and facilitate a technology grant for programs who receive coaching. As of 11/30/22, 306 child care programs applied for coaching. Some are assigned to a waitlist while we hire and onboard the new staff. All applicants can start using the Child Care Management System of their choice (brightwheel or Playground) even if they are on the waitlist.

Erika Fuentes, Director of Child Development, Crittenton Center – Resource Center has been actively doing outreach in Ida County and have attended four different community events.

The Crittenton Center has partnered with Mercy One Hospital and has secured space for hospital staff's employees at Stella East.

Linsey Gilbert, Child Care Nurse Consultant, CAA of Siouxland – Very busy with Influenza, RSV, and Covid illnesses. She has seen the closures of rooms and entire programs due to illness. There is a lot of co-infection (simultaneously testing positive for

more than one virus at a time) resulting in children being flown to the children's hospital in Omaha. Historically, RSV impact infants and toddlers but they are seeing it exploding in the older 5-year-olds this year.

Very busy assisting child cares getting the new quality rating system (IQ4K) up and going. Has been doing lots of med administration trainings.

Stacy Eldridge, Concept Manager, Building Blocks & Apple Tree – Also dealing with a lot of sickness right now. Both staff and students our with various illnesses.

Lexy Klemish, HOPES Program Manager, SDHD – The are currently working on their Healthy Families America Accreditation which is a very large undertaking and group effort across the HOPES Family Support Programs with a deadline of June 2023.

Interviewed someone for the bilingual Referral Specialist and they have a new Family Support Worker that has HS experience.

Have one family currently enrolled in Ida County.
