# **Woodbury County DCAT Recommendations**

# **Transfer of Funds**

Transfer of funds from JCS to Woodbury County DCAT in the amount of \$188,218.62. These funds will be applied to any FY19 DCAT service contracts that need to be covered and then carried forward to be applied toward FY20 DCAT service contracts.

### **FY19 Contract Amendments**

- Adding \$42,000 to DCAT1 18-032 DCAT Program Coordination due to the need for increased services. Contract total will be \$112,000.
- Adding \$15,000 to DCAT1 15-078 Juvenile Court Care Coordination due to the need for increased services. Contract total will be \$385,000.
