January 11th First day of session - Governor Reynolds delivered her annual Condition of the State Address on Tuesday, January 12, 2021 at 6:00 -

Reynolds says she wants to allocate \$3 million toward public-private partnerships to develop **child care** facilities. Another \$25 million in block grants would promote **child care** startups. Good start

QSP - <u>**SLIDE 1**</u>

QSP or (Quality Services and Programs) is A *component group that is responsible for investigating and promoting quality practices for the Early Care, Health and Education system.*

The component group was made up of 3, now 4, primary workgroups.

Early Childhood Positive Behavioral Interventions and Supports (PBIS) -

State Child Care Advisory Group -

Family Support Leadership Group

and we have recently added back in Project Launch - with their Early Childhood Infant Mental Health lens

Co-Chairs of these 4 groups serve as members of the QSP Leadership Group and bring their knowledge and expertise!

These groups meet regularly throughout the year and report back to the QSP group with their progress, to poise questions, and gather feedback!

With the invaluable support of the ECI state office the QSP Leadership group is now scaling up.

As stated, we currently have membership from the 4 workgroups, but are adding other at large members as well- based on knowledge and interest, including that of the ECI State Board as well as other local entities. We have a great group of thinkers who care about Early Childhood and want to continue to build on those efforts!

We are meeting quarterly via a virtual platform and spend a great deal of that meeting time discussing the work being done in the committees - brief updates from each are as follows:

EC PBIS: PBIS training modules for family support exist and the EC-PBIS committee has formed a PBIS Scale-Up Workgroup to focus on family support and utilizing the current PBIS training modules and next step considerations. Once the training is updated the group will need to coordinate a dissemination plan/ scale-up. The new ECI website will feature an Early Childhood Mental Health page. In FY21 we anticipate beginning a pilot with 10 early learning programs to utilize a new data-system to collect EC-PBIS data (data on coaching sessions, training, environments, ect.). A universal data-system (I2D2) will help inform and strengthen EC-PBIS strategy use and outcomes.

SCCAC - The State Child Care Advisory Committee has utilized systems thinking tools to reflect upon the current status and needs of child care at a system level. The subgroups have been focused on how child care can be supported during COVID and reviewing current child care guidelines for centers. While these two topics are not solely connected, they are in conversation simultaneously as these were two emerging needs. The State Child Care Advisory group will meet quarterly while the two subgroups meet more frequently in attention to the two emerging needs.

FSLG: Lunch and Learns began about 2.5 years ago with the goal to share available resources for professionals working with families. Lunch and Learns are hosted on the third Thursday of the month, with a repeat on Friday at noon. During COVID, Snack and Shares began on Mondays at 3:00pm. Topics for either virtual connection have been generated from participants in the virtual meetings and/or from the family support field

(users of DAISEY and now extended stakeholders based on their outreach to be included). We are going to add these events to the new ECI website *Events and News* page which will extend the reach!

And the newest Committee is Project Launch - There have been multiple presentations to the Children's Behavioral Health System State Board and partners across ECI have been focused on presenting strategies and supports for prevention. The board has currently been focused on crisis care. There are many topics of concern and planning conversations for the board are still underway.

Project LAUNCH, which currently has a grant from August 2019- August 2024, recently conducted a workforce study to identify current consultants, sectors the consultants work in, current professional development needs, etc. An executive summary will be drafted and will help inform the next steps for reflective consultation. Currently, twelve mental health consultants will be receiving reflective consultation this year. An Alliance of states will be developed in 2021 to begin to support each other in moving from pilot projects to statewide initiatives.
