## 2. Action Items

A. Shared office space @ 505 5<sup>th</sup> Street

## Matt Ohman

SHIP has found space at 505 5<sup>th</sup> Street that can serve as a shared space for SHIP, Sky Ranch Behavioral Services and Urban Native Center:

- location is 505 5<sup>th</sup> Street, Suite 100 in the Francis building (formerly Heritage Bank)
- space will be collaboratively occupied by Sky Ranch, Urban Native Center and SHIP
- Sky Ranch will be the lead agency and lease holder
- total sq ft is 5,400
- Lease is for 3 years January 1, 2024 December 31, 2026
- total cost per month is \$5,100 (under \$1/sq ft, current market rate for downtown is \$1.56/sq ft - thanks Jessica!)
- Rent covers all utilities except internet, phone and security
- Cleaning services and snow removal are provided by the landlord
- Space has nighttime access Sky Ranch and Urban Native both have needs to serve clients after business hours (currently Sky Ranch employees have to come down 5 floors to let youth in the building after hours)
- SHIP will retain its current office at 2540 Glenn; the new space will house at least 1-2 SHIP employees and have temporary work spaces for others
- SHIP's space will consist of 2 permanent offices and a meeting room or potential Board room
- SHIP's portion of the cost is **\$800 a month** plus costs for internet and phone, and parking for employees who don't currently have downtown parking passes; SHIP's total cost over **3 years is \$28,800**.
