## Tour of Harry Hopkins facility

SHIP Board member Gary Niles gave some SHIP staff a tour of the Sioux City Community School District's Harry Hopkins facility on January 23rd, where Gary and his brother are teaching students construction. We walked through two houses being built at the facility, one for Habitat for Humanity. Gary and his students are busy building the houses and many other current and upcoming projects for the District's facilities.

# **Downtown Partners Crime Prevention meeting**

I continue to participate every other month in the crime prevention meeting. In addition to Downtown Partners, the SCPD, the Library and the City's Neighborhood Services all give updates on issues, happenings and initiatives. At January's meeting, Ragen Cote shared the results of the Downtown Residents survey.

# **Briar Cliff University Social Work Department Advisory Committee**

A few years ago, I was asked to join the Advisory Committee for BCU's Social Work Department. We met on January 26th for a luncheon and got updates on BCU's current offerings for students, then met in groups to brainstorm solutions to the barriers in place for students wishing to pursue bachelors and post-graduate degrees in this field. I've found this connection to BCU, much like our partnership with Morningside University, has always been a good conduit for interns and student projects.

#### **HHS Re-alignment meeting**

As we received news that the Iowa Legislature will likely hold off on their re-alignent of Early Childhood Iowa, DCAT, CPPC, Community Action Agencies and public health until next year's session (they appear to be focusing on mental health and AEA, among other things this year), we convened our local group on January 29th to discuss and develop strategies. Our group consists of SHIP, Siouxland Mental Health, Siouxland District Health, Community Action Agency. We agreed to meet monthly unless we have reason to meet more often.

#### **Sanford Center tour**

It's been a long time since I've been to Sanford Center, so Jenna and I met with Fitz at their newly remodeled main office on Geneva Street. We learned about their before and afterschool program at Geneva and their Morningside location, their summer program, their at-risk prevention classes, and their outreach program. We will continue to discuss how SHIP and Sanford Center can potentially partner in the future.

# **Expand Magazine interview**

Kerri and I were interviewed by Stacie Anderson of Expand (formerly Siouxland Magazine). The pre-recorded Zoom will air on Facebook Live on Wednesday, February 21st. Also included will be podcasts and a spread and article on SHIP in the upcoming issue of the magazine. This is part of my effort to "expand" awareness and marketing for SHIP.

## Meeting one on one with SHIP Board members

Every year, one of my goals is to meet with each SHIP Board member one on one, whether that's over lunch, coffee or just an in-person meeting. So far in the New Year, I've met with SHIP Board members Treyla Lee and Jarod Mozer. BTB will not continue an afterschool program next year in South Sioux City schools. The YMCA will take over the afterschool programming with a parent fee structure at the Y location only.

Summer 2024 enrollment will be open next week.

The program is being restructured to offer programming "blocks" to the different age groups, and incorporating STEM, Arts, Music and Physical Education as well as general education. Field trips will now align directly with topics that the students are learning during their blocks.
