## E. BOOST BJA grant application

SHIP is applying for a U.S. Department of Justice Bureau of Juvenile Affairs grant to continue the BOOST Program. The new grant will be titled "BOOST Re-Entry".

Grant duration: 42 months, beginning October 1, 2022

Population served: Individuals age 18+ who are incarcerated but returning to their communities

# served: 100

**Funding**: \$900,000 SHIP indirect cost: 10%

**Program partners**: Iowa Workforce Development, Juvenile Court Services, Residential Treatment Facility (RTF), Woodbury County Jail, Global Foods, Tri-State Drywall, Hirschbach, Carpenter's Union, Seaboard Triumph and Unity Point Health -St. Luke's

**Program purpose**: To provide seamless pre- and post-release customized reentry and career services. Individualized services focus on career and criminogenic assessment, reentry planning, career planning, placement, retention, career advancement, support services and follow-up.

## Iowa Economic Development Authority, Nonprofit Innovation Fund

The Iowa Economic Development Authority, Nonprofit Innovation Fund is a \$20 million investment to assist nonprofit organizations meet the increased demand for resources following the COVID-19 pandemic. It provides grant to help nonprofits that have struggled to invest in much-needed infrastructure. Iowa's nonprofits have experienced financial hardships, driven by a significant decline in financial contributions, while the number of individuals seeking their services has increased.

The Urban Native Center will be the applicant for the grant and SHIP will serve as the fiscal agent. \$3 million will be the ask to begin site development and obtain architectural services/acquisitions for a new community center. There is a 10% requirement on this grant which will be identified by Urban Native Center. SHIP will charge it's standard 10% de minimis rate for administering the funds.

The grant application will be available via iowagrants.gov starting June 27, 2022 and grants will be reviewed on a rolling bases through December 31, 2022. All funds must be obligated by December 31, 2024.

# 0-3 Prime Age to Engage

On May 26th, the 0-3 Early Literacy committee delivered a bookshelf to Catholic Charities. The bookshelf was built and donated by the Carpenter's Union, with artwork by Dave Parker of Carpenter's. D2: Worldwide provided free used books. The Siouxland Community Foundation provided a grant to SHIP for the bookshelf materials and new books that I also put into the shelf. This is the 24th 0-3 free book shelf that we have installed into the community since 2018!

#### **Hope Street of Siouxland**

Hope Street celebrated the opening of a second location at 1918 Douglas (formerly Claire House). The newly named "Prosperity House" welcomed Governor Reynolds to help with the ribbon-cutting. This second location, which has been running since January, serves as a transition from the original building (Frank LaMere House) for those that are doing well and working, but still need a sober living environment prior to moving into permanent housing. Prosperity House can host up to 6 men at a time.

#### **Prevent Child Abuse Iowa**

On June 8th, we welcomed representatives from Prevent Child Abuse Iowa at the Ho-Chunk Centre for lunch and a site visit for the grant SHIP administers for the Urban Native Center. Val Uken, Manape LaMere and his companion Sunrose, Diane Smith and Shane Frisch from DHS, Val's staff from Urban Native, and Erin, Kim and I all spoke on the incredible progress and positive changes resulting in the Native community.

## Finance Updates:

- We have tentatively scheduled our audit with KRP to be conducted during the first two weeks of November 2022. This will be the third and final year on our current contract. An RFP for auditing services will have to be disbursed.
- Considerable work is going into spending down current grants and contracts. Finance is working with applicable programs and directors to build comprehensive plans to spend dollars according to budgets or complete and submit the necessary budget modification requests to meet program needs.
- We were successful in requesting the allowable carry-over dollars for the Beyond the Bell 21st Century grants. Across the three cohorts, we will be allowed to carry forward \$64,992.50 of unspent funds to be utilized during the next fiscal year.
- Finance is preparing to close the fiscal year as of June 30th. As of July 1st, we are implementing a new P&L chart of accounts that will create cleaner financial reporting and more accurate mapping of our functional expenses for the audit.
