a. DCAT update

Town Hall Meeting

SHIP put on a Town Hall meeting in collaboration with Siouxland Mental Health, Siouxland District Health, and Community Action Agency of Siouxland, on Monday, August 7th at the Sioux City Public Museum. The topic presented was the Department of Health and Human Services' (HHS) evaluation and assessment of all the community services and programs that now fall under HHS, including Early Childhood Iowa, DCAT and Community Partnerships to Protect Children. We wanted policymakers to know about the truncated process and looming deadline for this assessment, as they will be presented with recommendations for session in October. This was a great opportunity to show that our community organizations work very well together! Many thanks to the entire SHIP team for helping set up and organize the meeting, and to Kerri for getting the policymakers in the room and aware of the issue.

Ovation

Two SHIP Board members, Karen Mackey and Rita Frahm were honored at the 2023 Ovation ceremony at the Expansion Center in downtown Sioux City on June 28th. Ovation, presented by the Iowa Women's Foundation, is a tribute to Iowa women and girls whose hard work and dedication make change with lasting impact. The current format is a book published annually with pictures and stories about all of the women honored. In addition to Karen and Rita, other Siouxland women honored were Mandy Engle-Cartie (Girls, Inc.), Deb Bernstein LaCroix (Siouxland Expansion Center), and Brigadier General Stephanie Samenus (Iowa Air National Guard).

Ready to Serve

On July 27th, I was asked to be on a panel for Ready to Serve, a new project of Growing Community Connections. Ready to Serve are free, voluntary classes at Northeast Community College in South Sioux over a series of weeks that encourages emerging leaders and citizens to

serve their community on nonprofit boards, civic committees and to run for local political offices. My panel was asked to speak about non-profit boards. The other panelists were Travis Morgan, SHIP Board member Treyla Lee and Semehar Ghebrikidan.

d. Siouxland Street Project

A Street Project meeting is scheduled for September 19th at the Sioux City Museum from 9-11am. The project began collecting data in 2016 which helped to bring back federal funding for our Native community. In 2022 the group conducted 97 interviews with the homeless. Siouxland Coalition for Homelessness will be taking over this project. Moving forward a focus group with be working with landlords.

e. Beyond the Bell

Summer Program 2023 This summer we served 260 in our Sioux City schools, and 165 in our South Sioux City schools. Overall, the summer program was a great success and a key highlight I'd like to share is the middle school bike club. With support from Simpco 5210 grant, and MRHD discretionary funds, Rob was able to work with Albrecht Cycle Shop to purchase 20 bicycles, and helmets and give these students the experience of a lifetime. For some students, this was the first time they had ever rode a bike, for others this was the first time they rode outside of their own neighborhood. We also got a shout out on Facebook from Bob DeSmidt, a participant in the Trail Blazers Program, when he ran into our bike club on the trails and issued our students "tickets" good for a free Dairy Queen ice cream cone for wearing helmets.

School Year 2023-24 Jalisa and Jenny have been hard at work since early June to recruit and train staff to get us ready for the school year. They have implemented some changes in the process that are proving to be successful- electronic paperwork, group interviews, HHS online training done in advance at our office, and a week of onsite training prior to starting.

The team has been working hard to make phone calls to all of the families to properly communicate the status of their enrollment.

4. Board Education: BOOST Re-Entry

The BOOST Re-entry program will enroll participants ages 18 + who are currently incarcerated in or returning to Woodbury County but set for release in 180 - 20 days. Participants will enroll in the program. During this time, they will have the option to receive support in obtaining their High School diploma equivalency, explore careers, participate in training for employability and prepare for employment. Participants will have an option to obtain Industry recognized certificates and enroll into apprenticeships. These trainings can lead to jobs and higher wages by developing the skills and knowledge required in the workforce and holds the promise of reducing the recidivism rate of ex-offenders by improving their vocational and educational skills, and long-term prospects in the labor market by increasing their sense of responsibility. Participants in the program will learn valuable skills such as: punctuality, reliability, work ethic, life skills, and leadership skills. BOOST Re-entry participants will become an asset to their communities and will become better prepared to face challenges in their own lives.

Total number of enrolled participants to date – 16 (Enrollment started on July 12th) 6 – Native American, 5- Hispanic, 1-Pacific Islander, 1- Sudanese, 3 – Caucasian

Outcomes as of 8.16.23

5 participants have received a certification in Industrial Forklift with Innovative Business Services 7 participants have received Emerge employability training with our partner Iowa Works (State recognized training for those coming out of incarceration or with a criminal past) 4 inside Woodbury County Jail – 3 outside

10 are currently employed

3- will start working towards GED Hi Set

0-recidivism / Current recidivism rate for Woodbury County FY23 revocation rate to prison is 13%

11 – Dept of Corrections Residential Treatment Facility

5- Dismas Charites Federal Halfway Home

Revisited partnership with North Central Correctional Facility Minimum Security Prison in Rockwell City, Iowa. Providing support to those being released back into Woodbury County. Zoom call is set up to discuss programing with inmates soon to be released.

Our goal is to provide educational, employment and re-entry support to 100 individuals returning to Woodbury County. BOOST will have 25-30 individuals in 6-month Cohorts to provide quality services.
