## D. Policies

Early Childhood Iowa funding process

#### Matt Ohman

Early Childhood Iowa – Funding Process

SHIP, as the designated Early Childhood Iowa Area for Ida and Woodbury Counties, will annually award funding to local agencies. The funding cycle for Early Childhood Iowa (ECI) grants will be two three years, with the 2nd and 3rd years of the 2 3-year cycle designated as a renewal years.

Year 1

SHIP will issue a Request for Proposal (RFP) that will be sent out to the ECI distribution lists and posted on the SHIP website. The application process is open to all programs in the community serving children and families 0-5, whether new or previously funded. Applications will be reviewed and scored by the SHIP ECI Grant Review Committee. All applications must address one or more of the established SHIP Early Childhood Iowa Community Priorities. The Grant Review Committee will make funding recommendations based on overall scores and availability of funding. The Committee' s motion(s) will be presented to the SHIP Board for final funding approval. Programs will be notified of funding status and the contracting process will begin. Year 2 and 3 (Renewal years)

SHIP will issue a Request for Information (RFI) from applicants funded in the previous grant year. No new applications will be considered, and current contractors must justify any request for increased funding – no funding increase will exceed 10%. Contractor requests will be reviewed by the SHIP ECI Grant Review Committee. All requests must address one or more of the established SHIP Early Childhood Iowa Community Priorities. The Grant Review Committee will make funding recommendations based on the program' s progress and performance in Year 1 of the funding cycle, and the availability of funding. The Committee' s motion(s) will be presented to the SHIP Board for final funding approval. Programs will be notified of funding status and the contracting process will begin.

**Appeal Process** 

Applicants have the right to appeal the funding decisions based upon a showing that the

policies and procedures governing the grant selection process have not been properly applied. The appeal process begins on the postmarked date of the written notification to the applicant of the grant committee' s decision. Appeals should be in writing and filed with SHIP within ten working days of the date of written notification of funding decisions to the applicant. It is the responsibility of the applicant to assure that appeals are received by 4:30 PM on or before the tenth working day of the appeals process. Appeals received after 4:30 PM on the tenth day will not be reviewed. All appeals shall be delivered to the office of the SHIP Executive Director.

Early Childhood Iowa – Program Monitoring All programs funded with SHIP Early
Childhood Iowa dollars will receive one site visit per contract year funding cycle.
The Early Childhood Iowa (ECI) Director will conduct the site visit and will arrange
a time with the contractor. Site visits may include, but are not limited to, an
interview with the program director and staff, observation of program staff
working with program participants or students, and a review of programmatic,
participant, and fiscal files. After the site visit, programs will receive a report
summarizing the site visit and any resulting findings. Programs may be asked to
complete a corrective action plan within a specific time frame following the report
issue. All site visit reports, communication and follow-documentation will be
placed in the program file. A member of the SHIP Finance team may accompany
the ECI Director on the site visit.

I've been to the campus several times over the last month:

### Branding and Advertising Class

SHIP has been selected as one of 5 organizations (including 3 businesses and 1 other non-profit) that will work with a dedicated group of students during the fall semester that will come up with a marketing and branding campaign as their class project. I've shared with the students that I'd like to increase the general public's awareness of SHIP and all of its impactful programs – Beyond the Bell, BOOST programs, Sky Ranch, and the community initiatives like the Siouxland Street Project. We've talked about improving SHIP's social media presence and website, as well as short-form video production and other marketing. The students will present their ideas to me next Thursday, and we will begin implementation.

## Morningside Work Study MOU, Career Fair and Career "Dating"

On August 24th, we met with Morningside's Work Study program to offer students' the option to work at Beyond the Bell for their work study jobs. We finalized and MOU and then Jenna and I attended a career fair of all work study partners – we met with several students and got 6 applications. We hope to continue this partnership with the University for many years. On September 13th, Jalisa and I attended a "career dating" fair on Morningside's campus and talked to many students interested in going into non-profit management, social work, education and business careers.

### Siouxland Mental Health Ribbon Cutting

On September 8th, Kerri and I attended the ribbon cutting at Siouxland Mental Health's new Child and Adolescent Center at the former Pier 1 building. We also took a tour of the new facility.

Matt also noted that the Iowa Governor Volunteer Committee nominated Tom and Barb Small and awarded Jessica Ryan the individual volunteer award.

4. Board Education: Ida County Early Childhood Iowa Programs Providers Kevin Grieme - Siouxland District Health Department noted the challenge they face in Ida County is the lack of referrals. SDHD WIC program offers services in Ida County the first Wednesday of the month.

Erica Fuentes – Crittenton Center's Family Resource Center serves Ida County as well as Woodbury. Ida County families can receive parenting trainings individually or through group sessions.

Shari Smith – Mid-Sioux Ida County Preschool provides a school ready program Monday – Thursday 8:30-12:30. Eight of the slots in the program are funded by SHIP ECI. A challenge has been finding students who meet the income eligibility guidelines – up to 200% of poverty. Discussion by the Board was that students up to 215% of poverty may be accepted into the program, and if there are any families above that, it can be taken back to the Board for approval.

Mid-Sioux works with the iSmile program and provides home visits twice a year setting goals with parents.
